This certificate confirms the full disclosure of potentially hazardous chemicals in products. This ensures material transparency.

HPD-certified products such as Topakustik elements qualify for numerous green building programmes, such as USGBC LEED v4 MR, Google Portico, WELL Building Standard® and LPC Living Product Challenge LPC.

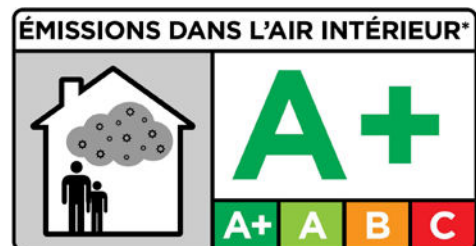


French VOC Regulation – A+

Volatile organic compounds (VOC) evaporate easily. Class A+ stands for particularly low-emission products. This includes the products from Topakustik.

Emission-tested building materials and products make an important contribution to pleasant and healthy indoor air quality, especially in today's increasingly well insulated rooms.

From the builder's point of view, products with a VOC certificate make it easier to obtain the BREEAM certificate.



NAF – No Added Formaldehyde

Topakustik produces with carrier boards – no added urea formaldehyde as standard.

For the surfaces, Topakustik uses water-based lacquers with a low VOC content as standard.



ISO – International Standards Organization

The ISO-certified quality management system of Topakustik increases transparency in operational procedures, optimises processes, improves customer satisfaction, and reduces the error and reject rate. For many clients, the ISO 9001 certificate is a mandatory prerequisite for cooperation.

The standards themselves are constantly adapted to new conditions and social and economic developments.
